


Youth unemployment, 2019 (% of labour force aged 15-24 years)







(% of total population, 1 January)




#### **Employment rate, Armenia and EU-27**




#### Unemployment rate, Armenia and EU-27, 2019



#### Distribution of the economy by sector, Armenia and EU-27, 2019




Youth unemployment, 2019 (% of labour force aged 15-24 years)















#### Real change in gross domestic product, Azerbaijan and EU-27


#### Population by age group, Belarus and EU-27, 2019

(% of total population, 1 January)





(% of total population, 20-64 years old)




#### Unemployment rate, Belarus and EU-27, 2019

(% of active population 15-74 years old)










#### Population by age group, Georgia and EU-27, 2019

(% of total population, 1 January)




#### **Employment rate, Georgia and EU-27**

(% of total population, 20-64 years old)




#### Unemployment rate, Georgia and EU-27, 2019


#### Consumer price inflation, Georgia and EU-27

(% annual change)

















#### Population by age group, Moldova and EU-27, 2017




#### Unemployment rate, Moldova and EU-27, 2019

(% of active population 15-74 years old)




#### Consumer price inflation, Moldova and EU-27

(% annual change)









#### Real change in gross domestic product, Moldova and EU-27




#### Population by age group, Ukraine and EU-27, 2019









#### Real change in gross domestic product, **Ukraine and EU-27**

## Statistical cooperation with the European Neighbourhood Policy-East countries

#### **European Neighbourhood Policy (ENP)**

The European Neighbourhood Policy (ENP), established in 2004, reflects the European Union's (EU) wish to build on common interests with partner countries and commitment to work jointly in key priority areas, including in the promotion of democracy, rule of law, respect for human rights, and social cohesion. Through the ENP, the EU offers partner countries potential greater access to the EU's market and regulatory framework, standards and internal agencies and programmes.

On 18 November 2015, the European Commission and the High Representative of the Union for Foreign Affairs and Security Policy set out a joint Communication providing a 'Review of the European Neighbourhood Policy' in response to developments in several partner countries.

#### Eastern Partnership (EaP)

The EaP is a policy initiative launched in 2009 to deepen and strengthen relations between the EU, its Member States and its six eastern neighbours Armenia, Azerbaijan, Belarus, Georgia, the Republic of Moldova and Ukraine. Following a broad consultation in 2019, a Joint Communication of 18 March 2020 on the policy beyond 2020, Reinforcing Resilience - an Eastern Partnership that delivers for all outlines long-term policy objectives for future cooperation.

#### Statistics Through Eastern Partnership (STEP)

Statistics Through Eastern Partnership (STEP) is a regional cooperation programme in statistics funded by the EU and managed by Eurostat. It is being implemented in the six EaP-countries: Armenia, Azerbaijan, Belarus, Georgia, Moldova and Ukraine.

STEP is a three-year programme, which started in January 2019 with a total budget of EUR 4.7 million. It aims at strengthening the statistical evidence base through more and better quality official statistics.

STEP helps the partner countries' national statistical institutes (NSIs) to strengthen their institutional capacity and to produce and disseminate comparable and reliable statistics in line with European and international norms and standards in areas such as macroeconomic, social, business and trade statistics.

STEP's ultimate goal is to support evidence-based policymaking. It aims to ensure that statistical evidence is behind policy decisions and will work to further develop cooperation and coordination within the national statistical systems of the partner countries.

#### **Geographical coverage of ENP-East countries**

The data and their denomination in no way constitute the expression of an opinion by the European Commission on the legal status of a country or territory or on the delimitation of its frontiers.

- The data for Georgia exclude the regions of Abkhazia and South Ossetia over which Georgia does not exercise control.
- Data for Moldova exclude areas over which the government of the Republic of Moldova does not exercise control.
- Data for Ukraine generally have a break in series in 2014, since they exclude the illegally annexed Autonomous Republic of Crimea and the City of Sevastopol and territories which are not under control of the Ukrainian government.
